Available Protocols & Tools:

Protocol	High-Level Summary
VHAC Pulmonary Embolism Response (PERT) Protocol	Standardizes rapid PE identification, risk assessment, and coordinated treatment to reduce delays and improve survival.
Shock Protocol	Provides early recognition criteria and stepwise escalation (including mechanical support) for managing cardiogenic shock.
AKI Reduction Recommendations	Offers best practices to prevent acute kidney injury through optimized fluid, contrast, and medication management.
Atrial Fibrillation Prophylaxis Protocol	Outlines prevention and treatment strategies to reduce postoperative atrial fibrillation after cardiac surgery.
Prolonged Ventilation Protocol	Guides early extubation readiness and respiratory management to shorten ventilation time and prevent complications.
Readmissions Protocol	Standardizes practices across the care continuum to lower cardiac surgery readmission rates.
Readmission Calculator Toolkit	Identifies high-risk patients using a prediction tool and provides planning resources to prevent readmission.
Data Manager FTE Recommendations	Recommends appropriate staffing levels for accurate, timely registry data abstraction and reduced workload strain.
RBC (Red Blood Cell) Protocol	Establishes evidence-based transfusion thresholds and conservation techniques to reduce unnecessary RBC use.
